Teams include teaching assistants, classroom aides, student support teachers, counselors, and health office personnel. AIS programs are provided during and after school and include: student support center, small group instruction, additional intensified instruction, after-school learning labs, counseling, computer lab, and one-to-one instruction.
	This grant sets aside monies to fund training, planning, and implementation of the RTI Model or AIS in the District. This teacher will continue to train other staff in the RTI Model, assessments, and progress monitoring.
	Reading/Literacy Specialist – to support teachers and the use of effective reading strategies including proper use of our Fontas and Pinnell Reading Program. To work with struggling readers in need of Tier 2 and 3 RTI Services at the elementary level.

Personalized Learning improves student engagement and achievement, develops students to be lifelong learners, and better prepares them for college and careers.
