#### Letter from the Board of Education

Dear Residents:

The enclosed information details your Board of Education's proposed 2014-15 school budget. We are again fortunate to be able to work with solid numbers as the State Budget was passed in a timely fashion.

The goal of our district is to maintain student programs and propose a budget that is reasonable to the taxpayers in these challenging economic times. There have been a couple of important factors that have allowed the district to accomplish this goal. Through the cooperation of each bargaining unit, we have been able to change the health insurance benefit plan offered by the district. This change in plan will save our district a significant amount of money while continuing to offer our employees and retirees a comparable health plan. In addition, with an increase in state aid to our district, and the reduction of the state's Gap Elimination Adjustment, we have been able to maintain a flat budget as we move into the 2014-2015 school year.

Due to large cut backs in state aid and the gap elimination adjustment over the past three years, we needed to use reserve funds to help balance the budget while maintaining programs for all students. We are encouraged by the fact that we have been able to significantly reduce the amount of reserve funds being allocated in the projected 2014-2015 budget. We are proposing a 0.98% tax levy increase that is below our 2.04% calculated tax cap and a 0% (flat) budget to budget increase. The budget will remain the same as last year at \$8,858,730.

Please join us for the public budget hearing on Wednesday, May 7th. And please vote on Tuesday, May 20th. Thank you!

## **Voter Qualifications**

One of the easiest and most effective ways for those who are not actually in school to participate in the life of our school is to vote in school elections. To perform your civic duty and get a say in how your school tax money is spent usually takes about five minutes of your time, twice a year.

In order to be eligible to vote in school elections. School Law says a person must be:

- at least 18 years old,
- a citizen of the United States, and
- a resident of the school district for at least 30 days before the election.

While a voter's age and citizenship are relatively easy to determine, finding out a voter's residence can be a problem. Two tests can be used to help determine a prospective voter's qualifications:

- First, a person can have only one legal residence. Residence for the purpose of voting is the fixed and permanent home of the voter.
- Second, property ownership alone does not equal residency. Ownership of real property within a school district alone does not qualify an individual to vote in the elections of that district.

To ease the task of election officials to determine voter qualifications, the Board of Education has enacted a provision under Education Law that requires "All persons offering to vote to provide proof of residency which may include:

- a driver's license,
- a non-driver identification card,
- a utility bill

A driver's license with a 911 physical address is sufficient. A driver's license with a PO Box address will require an additional piece of identification with your physical (911) address.

Proof of residency will be required for the budget vote on May 20 and all school elections thereafter. We hope that any inconvenience caused by this extra step in voting at school elections will be outweighed by the increased confidence voters have in the result.

#### **Quick Facts**

- We are proposing a flat (0%) budget-to-budget of \$8,858,730.
- The projected tax levy increase of 0.98% is less than our 2.04% calculated tax cap.
- The change in the district's health insurance plan will save the district over \$350,000.
- We are able to decrease the use of fund balance and reserve funds in this budget by over \$275,000.
- We continue to take advantage of BOCES services that offer a cost savings to the district by generating BOCES Expense Driven aid. For example, we are looking at utilizing the services of five (5) itinerant teachers (shared) which could save the district approximately \$200,000.
- The governor and state legislators have been working to reduce or eliminate the Gap Elimination Adjustment over the next couple years. This has cost the district over two million dollars in state aid over the past four years.
- The proposed budget of \$8,858,730 less the building aid received (\$876,536) results in a budget total (\$7,982,194) for 2014-15 which is less than the 2008-09 approved budget of \$7,995,068.

#### Section 1608 or Section 1716 of the Education Law

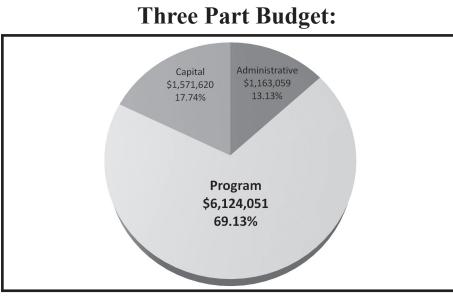

**Mr. Jerry Theis:** Jerry Theis and his wife Cheri have lived in the town of Butternuts for 36 years. He was first elected to the School Board in 1996, and has served as President since 2006.

Butternut Valley in 1979, because he loved the area. The shop was in operation until 2010 when Jerry "retired". He took on a position at Apple Converting in Oneonta in 2008, working in the Quality Assurance division and is still currently working at Apple.

Jerry's three children have all graduated from Gilbertsville-Mt. Upton, and are now living and employed in Chicago, Washington DC and NYC. Their education and that of all the children at GMU has been and always will be a very essential issue to Jerry. Although he no longer has children in school, in these tough and troubling times, Jerry's long term experience and knowledge with all the issues regarding your children's education would be a stabilizing factor in this turbulent time, when politicians are trying to cut more and more from our school. 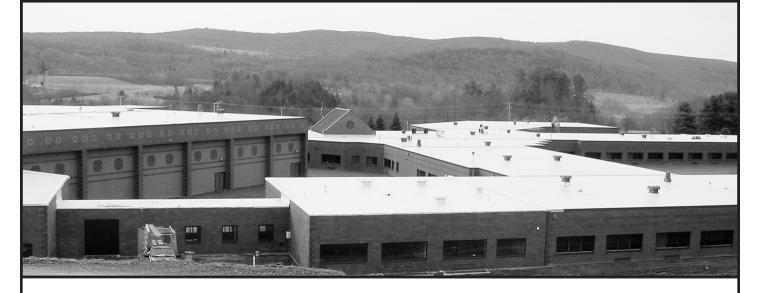
