Letter from the Board of Education

Dear Residents:

The enclosed information details your Board of Education's proposed 2015-16 school budget. For the fourth year in a row we are able to work with solid numbers as the State Budget was passed in a timely fashion.

The goal of our district is to continue to maintain student programs and propose a budget that is reasonable to the taxpayers in these challenging economic times. There have been a couple of important factors that have allowed the district to accomplish this goal. In addition, with a 3.72% increase in state aid to our district which included the elimination of all but \$8,960 of the States Gap Elimination Adjustment, we have been able to maintain a flat tax levy as we move into the 2015-2016 school year.

We are proposing a 0% tax levy increase that is well below our 2.97% calculated tax cap. This year we have been able to limit our budget to budget increase to 1.55% that results in a budget of \$8,995,610.

Voter Qualifications

One of the easiest and most effective ways for those who are not actually in school to participate in the life of our school is to vote in school elections. To perform your civic duty and get a say in how your school tax money is spent usually takes about five minutes of your time, twice a year.

In order to be eligible to vote in school elections. School Law says a person must be:

- at least 18 years old,
- a citizen of the United States, and
- a resident of the school district for at least 30 days before the election.

While a voter's age and citizenship are relatively easy to determine, finding out a voter's residence can be a problem. Two tests can be used to help determine a prospective voter's qualifications:

• First, a person can have only one legal residence. Residence for the purpose of voting is the fixed and permanent home of the voter.

• Second, property ownership alone does not equal residency. Ownership of real property within a school district alone does not qualify an individual to vote in the elections of that district.

To ease the task of election officials to determine voter qualifications, the Board of Education has enacted a provision under Education Law that requires "All persons offering to vote to provide proof of residency which may include:

- a driver's license,
- a non-driver identification card,
- a utility bill

A driver's license with a 911 physical address is sufficient. A driver's license with a PO Box address will require an additional piece of identification with your physical (911) address.

Proof of residency will be required for the budget vote on May 19 and all school elections thereafter. We hope that any inconvenience caused by this extra step in voting at school elections will be outweighed by the increased confidence voters have in the result.

Quick Facts

- We are proposing a 1.55% budget-to-budget increase to \$8,995,610.
- The projected tax levy increase of 0.00% is less than our 2.97% calculated tax cap.
- This year, the district's contributions to the Teachers' Retirement System and Employee Retirement System have decreased.
- Utilizing the BOCES Competitive Bidding process, combined with the drop of energy costs, we project significant savings.
- We are able to decrease the use of Appropriated Reserves and Appropriated Fund Balance each by \$5,000.
- The governor and state legislators have been working to reduce or eliminate the Gap Elimination Adjustment. The current Gap Elimination Adjustment has been reduced to \$8,960.



Proposed School Budget

Residents will have the opportunity to vote on the proposed school budget as listed in Proposition 1:

Shall the following resolution be adopted to wit:

RESOLVED, that the Board of Education be authorized to spend \$8,995,610 in the 2015-2016 school year for the education program of the Gilbertsville-Mount Upton Central School District, and to levy the necessary tax.

Establishment of a Capital Reserve Fund

Residents will have the opportunity to vote on the establishment of a new capital reserve fund as listed in Proposition 2:

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education of the Gilbertsville-Mount Upton Central School District is hereby authorized to establish a capital reserve fund pursuant to Section 3651 of the Education Law. This fund will assist the district in planning for infrastructure upgrades while minimizing the burden on tax payers. The capital reserve fund can be compared to a savings account which can only be used for capital improvements conducted with voter authorization. The funding comes from budget savings and unappropriated fund balances from the general fund. Balances can only be transferred to the capital reserve fund with approval from the Board of Education. In order to accomplish the same, said Board is hereby authorized to establish the ultimate amount of such Reserve Fund not to exceed \$500,000, plus accrued interest and other investment earnings thereon, with a probable term of ten years. If approved, this resolution shall take effect immediately and will have no impact on the tax levy.

Election of School Board Members

Mr. Larry Smith: My name is Larry Smith and I am seeking re-election to the GMU School Board. I am currently Vice President of the School Board. I live in Gilbertsville with my wife, Claudette Newman, who is an attorney, and our three children. Scarlett is 14 years old and in 9th grade our 12 year old twins, Ethan and Sadra, are in 7th grade.

I was born and raised in Gilbertsville with my family having lived here since the early 1800s. I am currently a semi-retired contractor having done carpenter work for

the past 28 years. I ran a Guest House in Gilbertsville for two years. I previously worked for the Town of Butternuts for seven years.

I am a member of the Gilbertsville Baptist Church. I currently serve on the Pastoral Relations Committee. I am a former Deacon and served for many years as Chairman of the Finance Committee, where I led the preparations for the annual church budget. I am involved in many sports, such as tennis, volleyball, ice hockey and running. I have played in the Binghamton Hockey League for the past 18 years. I have competed at the Empire State Games and won a bronze medal in the 200 meter sprint.

I am always accessible to members of both the Gilbertsville and Mt. Upton communities. I take the responsibility that I have been entrusted with seriously. Having a strong background in budgets, business management, negotiating and youth activities, I believe these experiences make me the right candidate for re-election to the GMU School Board.


